Call for Board of Directors Nominations

The USASP is looking to fill three Director seats on the Board of Directors. The USASP is committed to (1) transparency in the nomination and election process and (2) board membership that reflects the diversity of the membership of the USASP. Therefore, the USASP will accept nominees who meet criteria for any of the seats described below.

Eligibility Criteria for Open Positions:

Active member of the USASP in good standing

Recent experience serving on USASP committees or working groups, or comparable experience in other organizations.

Directors (three open positions)*:

Term: Three years

Directors on the Board provide advice to the President, in addition to providing guidance on issues brought to the USASP and support the Board's decision-making process. Directors are expected to serve concurrently on at least one USASP Committee and/or Task Force to serve as the liaison between the Committee and the Board. The below criteria for open seats have been defined based on required characteristics to balance the experience and expertise on the Board.

Seat 1: Mid- to Senior-career investigator (Assoc./Full or Senior Scientist/Director) whose primary designation** is Basic Research- non-Human

Seat 2: An individual from any career stage whose primary designation** is Basic Science-Human

Members interested in working with the Education and Professional Development Committee are strongly encouraged to apply

Seat 3: Mid- to Senior-career investigator (Assoc./Full or Senior Scientist/Director) whose primary designation** is Clinical Care and/or Patient Advocacy and/or Pediatric Pain



BOOK CORNER

A review of Drug Dealer, M.D.

How I missed this book when it was first published, I do not know. It is a very strong indictment of the medical profession as the primary cause of the early 2000's prescription opioid epidemic in the United States. The author is clearly angry at the role her professional colleagues have played in this contemporary disaster. Written before the full flowering of illicit fentanyl lacing multiple recreational drugs, it really addresses only the original epidemic, and not the more recent issues. The author is a well-known psychiatry addiction specialist at Stanford Medical School; she has been heavily involved in the many lawsuits related to the prescription opioid epidemic. What makes this book unique is the inclusion of case vignettes that illustrate how the medical profession has been oblivious to its role in producing drug abuse and addiction. As many have recognized already, much of the responsibility lies with the medical education establishment that has for too long ignored pain in general, and opioids in particular. We know that roughly 50% of the patients who seek health care have pain as their chief complaint, yet less than 2% of a medical school curriculum addresses this topic. This failure in foundational education by the establishment left an open field for industryfunded education with its overriding goal to persuade doctors that the answer to untreated pain was opioids. The author also implicates conventional medicine's fixation on biology at the expense of mental illness. Her focus is clearly upon the need to change how and why physicians write prescriptions. This book is yet another voice for improving medical education about pain and opioids in our medical schools. She offers no suggestions as to how to accomplish this task, but as many of us recognize, what is missing from medical curricula is not so much how to manage pain with opioids, but how to manage pain without opioids. This book is a good read and I highly recommend it.
